- **Approve expenditure of ARPA Funds for Storm Water Damage and Repairs \$3680.00 Benner Excavation.** *Richard motion to approve expenditure of ARPA funds as described, Jon seconded the motion, Dick said he went down and looked at it and Matt did a good job, no further discussion, all in favor, so moved*
