NEW BUSINESS:

- **Results of Special Open Town Meeting:** *Both articles passed with no oppositions.*
- **Selectboard to approve Abatement: Michael Campbell: 106 US Highway 1 for \$1656.32-reduction in assessed value from \$452,500. to \$323,100.-Jon motion to approve abatement for Michael Campbell, Richard second the motion, all in favor, so moved.**
- **Selectboard to approve Waiver of Foreclosure -on Thomas Moody & Pine State Recycling-** *Richard motion to approve Waiver of Foreclosure for Thomas Moody and Pine State Recycling, Jon second the motion, no further discussion, all in favor, so moved.*
- **Discussion on Calderwood Engineering Costs and future costs.-** *Richard spoke with Eric Calderwood about the DEP Stream Grant and that there is going to be a lot of applicants at the \$150K. It is based on the needs and impact for migratory fish. If we do not get it this year we can apply again for next year. Eric said he is going to take a soil test to determine it.*
- **Jon to discuss signage at Ballfield for patrons & their dog's remnants being left behind.** *It was in agreement that signage needs to be placed down at ballfield for cleaning up after patrons dogs.*
- **Rick Erickson- new street name for his subdivision- Wildflower Circle, Selectboard to vote for approval of name for his street.** *Richard motion to approve new street for Erickson's subdivision. The name will be Wildflower Circle, Jon second the motion, no further discussion, all in favor so moved.*

OTHER BUSINESS:- Update on meeting with Jon, Dale & Randy Butterfield-Maine DOT- *Jon said that he And Dale met with Randy & Jaqueline (DOT) They told Jon & Dale that they are not buying the culvert but they did agree to fix their drainage problem.*
