- **Aaron Bradbury & Kevin Rawley-Nobleboro Fire Dept**
  - Swear in Kevin
  - Aaron Resignation
  - R Spear thanked the FD for their time and patience with the transfer of chiefs.
  - R Spear excepted Aaron Bradbury's resignation as Nobleboro Interim Fire Chief
  - Kevin Rawley was sworn in as the Nobleboro Fire Chief
- **Approve 2024 Municipal Officers**
  - Emerald gave the selectboard the list of the Municipal Officers for 2024
  - R Spear explained that the selectboard will review the list and will table this until the next selectboard meeting on 6/5/24
- **Zachery Brown Abatement**
  - R Powell and R Spear reviewed the abatement.
  - Z Browns home was reported wrong length on previous property card. KRT found the discrepancy while assessing the home.
  - R Spear explained that Frank usually recommends abatement for 1 year
  - R Powell recommended 2-year abatement due to towns mistake
  - R Spear motioned to abate Z Browns property for 1 year in the amount of \$209.61

- R Powell feels that Duck Puddle rd. needs to be done but at low expense.
- M Benner was explaining that the road would need to be lifted 2' to 3' due to flooding.
